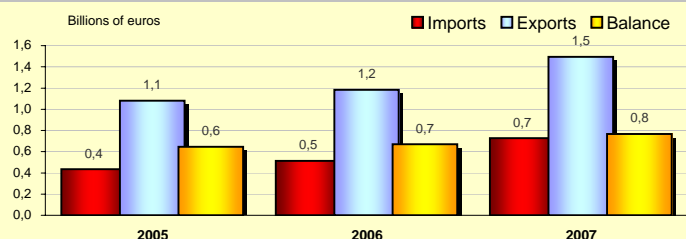

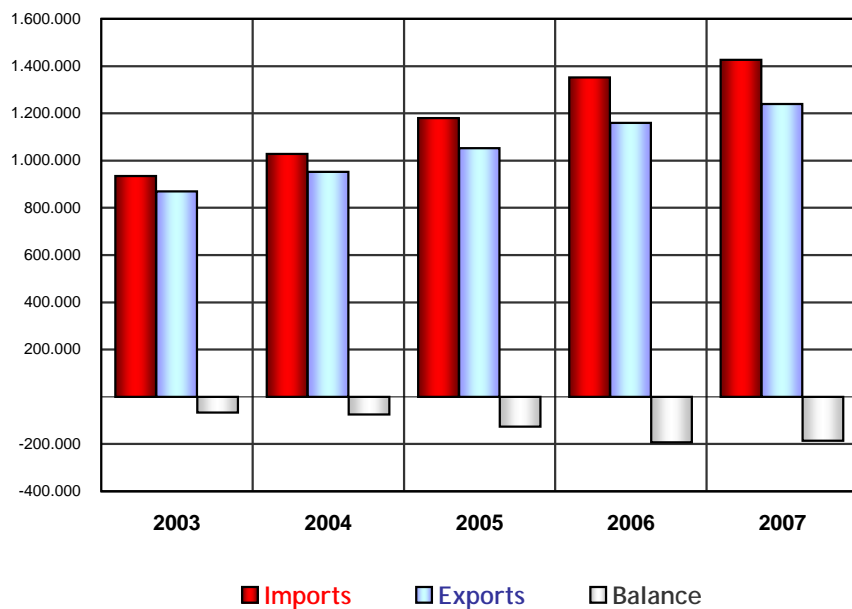

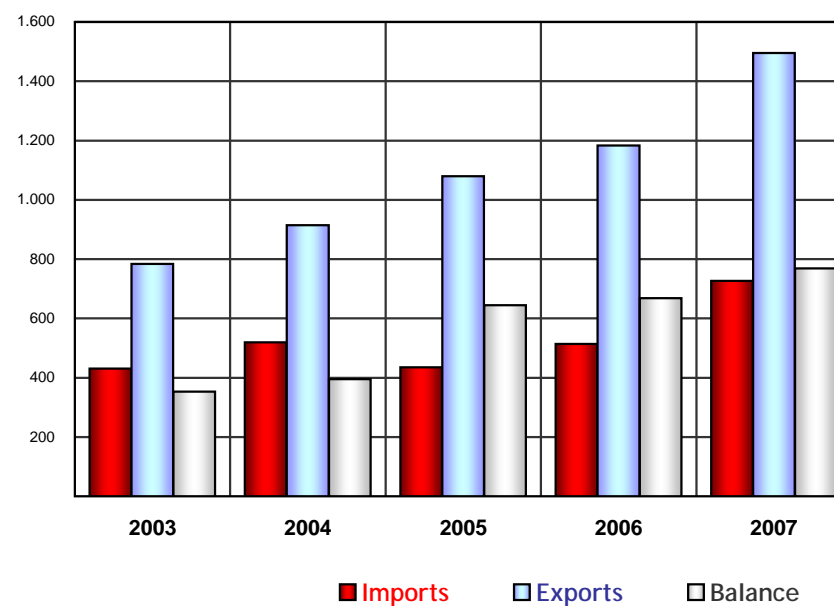

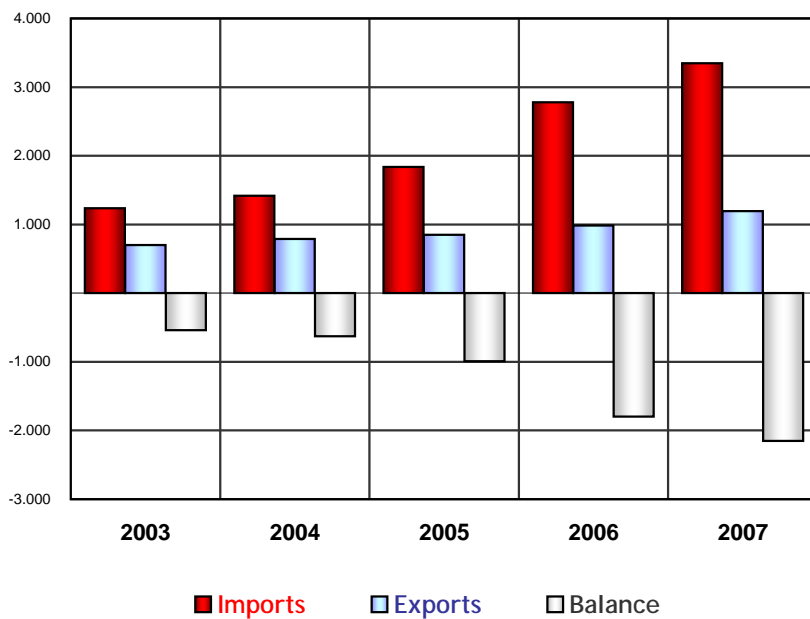

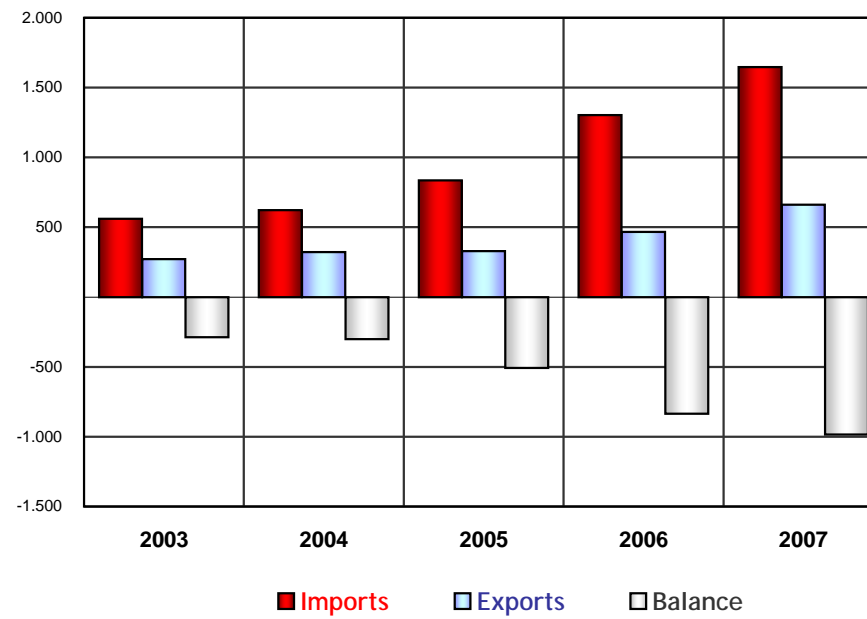

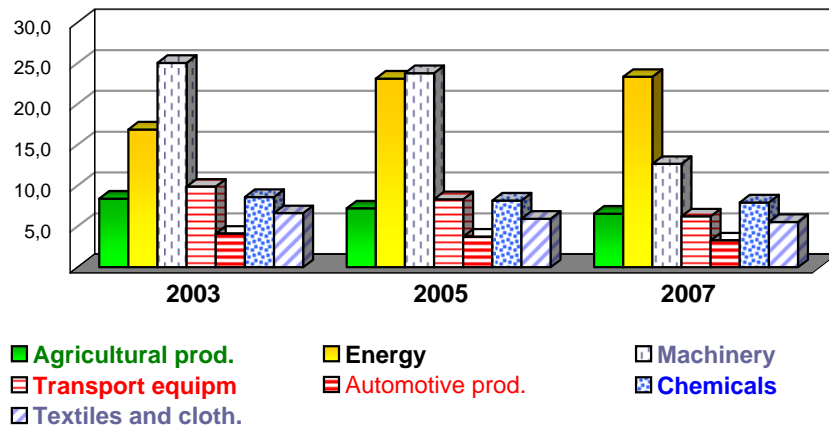

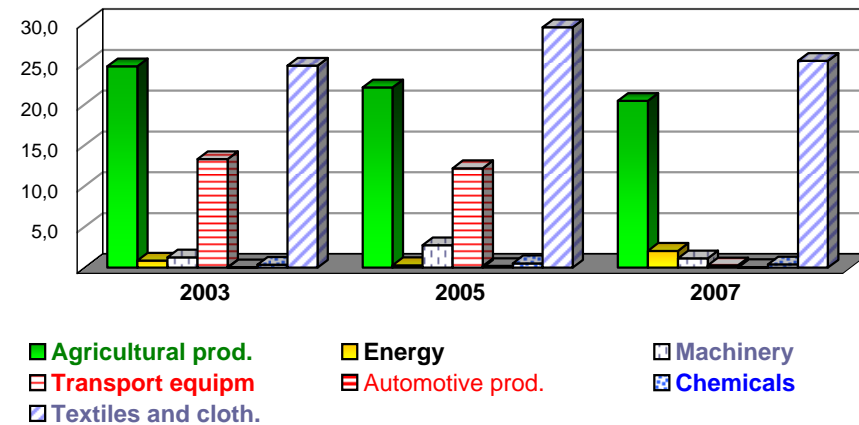

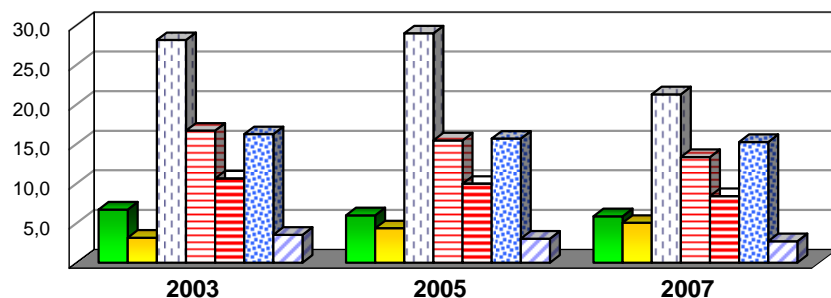

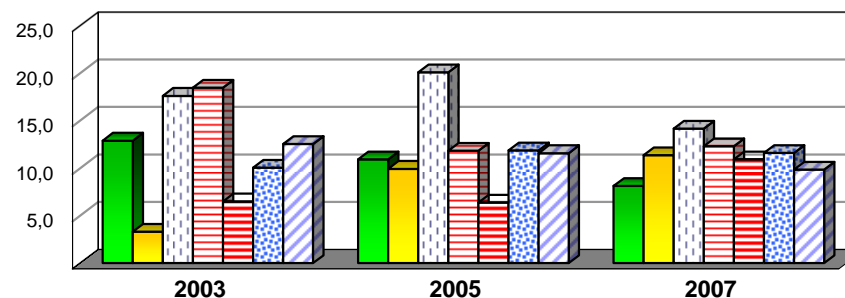
### Structure of Exports (%)

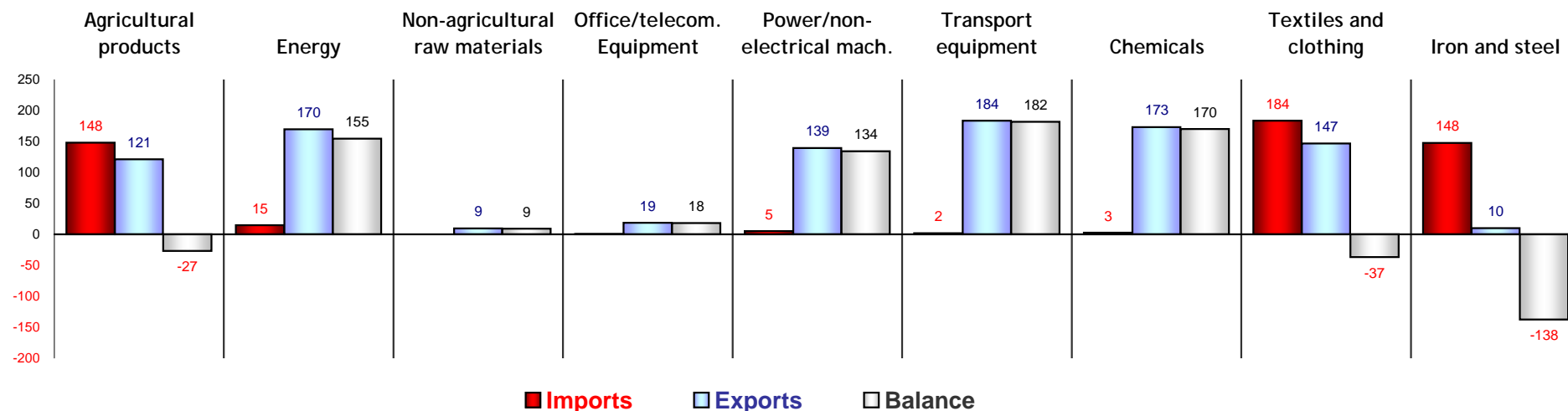
